During 2010, the Foundation expanded its community outreach with events such as our Annual Speakers Luncheon featuring Mississauga author Robert Sawyer, the Marathon of Golf, and our Donor Celebration. We were also pleased to participate in the Rainbow Ball, Estate Planning Council, Mississauga Board of Trade, Canadian Association of Gift Planners, Mississauga Summit, Living Green Planning, and more.

We have continued to strengthen governance and accountability activities, and are pleased to be one of the first Canadian community foundations with a web site page demonstrating our commitment to accountability.

As we move forward and celebrate the Tenth Anniversary year, we are mindful of the extraordinary growth we have experienced. By fiscal year end, the Foundation has in excess of \$16 million in endowed assets. As each of these ten years has passed, we continue to grow and to have greater impact on our community. It has all been made possible through the hard work and dedicated commitment of so many people. All we can say to them is thank you. We hope you feel as much pride in the vision, determination and impact of this young community foundation as we do. We look forward to what comes next!

# VISION

## FOR 10 YEARS, WE'VE BROUGHT VITALITY TO MISSISSAUGA. HERE'S HOW

The Community Foundation of Mississauga is an incorporated non profit, registered charitable public foundation. We are governed by a volunteer Board of Directors and are accountable to our community. We serve all of Mississauga, celebrating its many unique neighbourhoods and diverse voices.

The Foundation is a member of Community Foundations of Canada and part of a national network of over 170 community foundations. As a member of Community Foundations of Canada, we adhere to a rigorous set of standards, and build community vitality by sharing three core roles with our peers across the country:

- Vitality depends on long-term resources for long-term solutions—so **we work with donors to build endowment funds** that ensure vital futures for communities.
- Vitality comes from all corners of a community, so we **grant funds to the widest possible range** of organizations and initiatives.
- Vitality needs leadership, so we **bring people together from all parts of our communities** to stimulate new ideas, build participation and strengthen community philanthropy.



## OUR APPROACH

And while there are many organizations working for better communities, a few important factors make our approach special:

- We bring donors to the table as community builders, and help them formulate and realize their philanthropic goals, matching their interests and concerns with community needs and organizations, and finding innovative and responsible ways to give their investments lasting impact.
- We take the broadest view of what a community is and what it needs to succeed. This is why our grants support everything from shelter, sustenance and care for those most in need, to recreation, the arts, and the environment.
- We take the long-term view for our communities: we identify long-term needs and opportunities and invest in sustainable solutions, helping our communities become resilient, resourceful, and ready for the future they want.

# COLLABORATION

## BRINGING DONORS CLOSER TO THEIR DREAMS BRINGS GREAT THINGS TO OUR COMMUNITY

Creating endowed funds is the heart of what our community foundation offers to donors. People from all walks of life can create, or contribute to existing funds, which are held in perpetuity by the Community Foundation of Mississauga. ## **DONOR STORY: MENDEL COHEN EMBODIED THE SPIRIT OF GIVING, CARING, AND BUILDING**

It has been said that with a good friend, you can sit quietly, enjoying the peace of silence together. That may be true. But with Mendel Cohen as a friend, there was rarely silence. Mendel had many great stories to tell, loved to listen to others and find the laughter in life's challenges. Mendel was one of a kind.

Mendel married his sweetheart Ruth after spotting her as a pretty young woman in a Montreal restaurant. They enjoyed 40 years of marriage. Their home was filled with keepsakes and mementos from the far flung places around the globe that Mendel's job took the couple off to. When Mendel retired, they made their home in Mississauga and enjoyed the company of friends and family.

After Ruth passed away, Mendel wanted to find a way to honour her memory and support the community he cared about. He became involved with the young Community Foundation of Mississauga and his donations were pivotal in helping the Foundation sustain its core programs in those early years.

Mendel loved people, and enjoyed talking with them on any subject imaginable. Hours could easily slip away spent in good conversation with Mendel. He was a dedicated friend to the Foundation, its staff and volunteers.

In early 2010, the Foundation was deeply saddened to lose a dear friend when Mendel passed away. He left a further bequest in his will that will go on ensuring that our community is strengthened through the work of the Community Foundation of Mississauga.





## **GRANT STORY: OH, BABY! WHEN SUSAN NEEDED THEM, THE TRILLIUM HEALTH CENTRE WAS THERE**

Mississauga mom Susan Stephen never thought her new baby would spend the first twelve weeks of life in hospital. But 25 weeks into her pregnancy, Susan suffered a frightening complication because of high blood pressure.

Her own life in danger, Susan gave birth by caesarean section, and tiny baby Kathryn came to Trillium Health Centre's Intensive Care Nursery at eight weeks old, weighing just over four pounds. Kate was on a fetal heart monitor, oxygen sensor and feeding tube – she needed time to grow until she could safely manage on her own.

Susan and baby Kate's Dad, Jeff, visited every day until Kate could finally go home. "Trillium was a Godsend for us," says Susan. "The staff was so expert and kind. We were thrilled that Kate had such great care."

Electronic fetal heart monitors, respiratory equipment, obstetrical apparatus for patient comfort and safety – all these elements come together to ensure a healthy labour and delivery for the over 4,400 babies born at Trillium each year.

At Trillium, the use of fetal heart monitors has dramatically reduced the need for newborn babies to be admitted to the neonatal intensive care unit. In 2010, Trillium Health Centre Foundation received a grant from the Pendle Fund at the Community Foundation of Mississauga to help purchase fetal heart monitors.



## **DONOR STORY: CARING FOR THE COMMUNITY BEGAN AT HOME FOR THE SHOEMAKERS**

Brad and Kathy Shoemaker were one of the first fund holders and donors at the Community Foundation of Mississauga. Married for over twenty years, the Mississauga couple raised two sons. Kathy worked first as an accountant, then as an investment advisor, while Brad was a branch manager for a major investment firm.

Despite a hectic life, the couple found time for volunteerism, Kathy with her church, and Brad with a number of charities including ChildFind, Scouting, and as one of the founding Directors with the Community Foundation of Mississauga.

Brad and Kathy had been considering the idea of establishing a private foundation, and with their financial acumen, they knew the value of a permanently endowed fund. They soon realized that a community foundation

could help them accomplish their philanthropic goals more efficiently.

So they turned to the Community Foundation of Mississauga to establish their donor-designated fund. Such a fund ensures that the annual granting is directed to the charities they have named in their fund agreement. “We liked the idea of the asset existing forever and making annual grants,” noted Brad. “We knew the Community Foundation of Mississauga would always be there to protect our goals even when we were gone and financially it makes sense; the fund can grow year after year.”

Now Brad has changed careers and the children are almost grown, but there are some things that will remain constant. The Shoemakers are deeply committed to improving the quality of life for their community, to teaching the value of philanthropy to their children, and to leading by example.





## GRANT STORY: ERINOAKKIDS IS DRAMATICALLY IMPROVING LIVES

To be, or to be the best you can be – THAT is the question. Mitchell Lolli is a star who truly shines on stage because he is so outgoing and ready to connect. The Mississauga teen has Williams syndrome, which imposes developmental and physical challenges, but it's his abilities that you notice.

The drama program at ErinoakKids Centre for Treatment and Development, with support from the Pendle Fund at the Community Foundation of Mississauga, helps channel his abilities. Mitchell's a veteran of three onstage productions, and he's quite the showman with his Scottish drums at ErinoakKids events and annual talent show.

Brianna McGee is another star of the ErinoakKids drama program. Being born with Down syndrome, needing heart surgery at six weeks, and a number of physical troubles have challenged her. However, since becoming

a client of Ontario's largest Children's Treatment Centre at age three, she has had many successes. Drama has helped Brianna overcome many limitations associated with Down syndrome. Being on stage did not come easily for her, but the innovative program, taught by Drama Facilitator Danielle Strnad, lets her flourish. "Drama teaches focus and concentration, and helps kids reach out," says Strnad. "Reaching out is the key to being their best."

To help kids be their best means going beyond its government-funded programs, which is the reason ErinoakKids reaches out to its communities to support programs like this. The Pendle Fund at the Community Foundation of Mississauga supports this unique program, which would not be possible without private sector support.





## **DONOR STORY: CFofM HELPS HARMONY SPREAD FROM ONE FAMILY TO MANY OTHERS**

Gary and Joanne Reamey, together with their blended family of seven, feel blessed in so many ways that they feel it is their duty to assist those less fortunate. Their endowment with the Community Foundation of Mississauga enables them to do this.

Gary is a leader in his organization, and as a philanthropist, a committed volunteer to various organizations within the community. Joanne was an active volunteer even before they met. As a family, their focus remains a commitment to nurture healthy and safe environments for other families in need of support.

The couple chose to work with the Community Foundation of Mississauga because it's a well established, charitable organization dedicated to ensuring

endowments are protected, invested responsibly and delegated to the donor's charity of choice on an ongoing annual basis.

"The established endowment with the Community Foundation of Mississauga ensures our philanthropy wishes continue long after we are gone, removing the onus from our children", noted Gary.

The Reameys' charity of choice for granting from their fund is Interim Place, which provides support, assistance and shelter to women and children in need. It offers hope for a new beginning to women and children who've suffered abuse. Hope, not only for today, but also to future generations, to those who will be our leaders, teachers, mothers and fathers. Interim Place empowers women to take charge of their lives and of their futures.



## GRANT STORY: MASTERS OF THE FINE ART OF COMMUNITY IMPROVEMENT

Volunteer MBC promotes volunteerism to create caring, vibrant and healthy communities.

The RSVP (Retired Senior Volunteer Program) of Volunteer MBC provides retired seniors with opportunities to become socially engaged and contribute to the well being of their community.

Marielle, a retired professional who always had a passion for art, decided to volunteer her time at the Cawthra Senior Center. She teaches art classes twice a week to other seniors. Volunteer MBC invited her to volunteer for the Central Parkway Mural project, which revitalizes a crime and graffiti riddled neighbourhood in Mississauga. Volunteers paint murals, bridge rails, garbage containers and park benches, as well as planting shrubs and gardens that regain ownership of their neighbourhood.

Andrew, who attends PAS (Peel Alternative School), was one of the participating volunteers. Andrew and 16 of his classmates painted one of the nature inspired murals by the river at the Gordon Shipp Park. Marielle took Andrew under her wing, and they worked together beautifully. Andrew later told his teacher that Marielle was the first person who ever told him that he was actually good at something.

The RSVP program is changing lives. Together, local seniors are helping youth, families, other seniors, neighbourhoods and communities who face tough times.

The Community Foundation was proud to provide Volunteer MBC with a grant supporting the RSVP program.

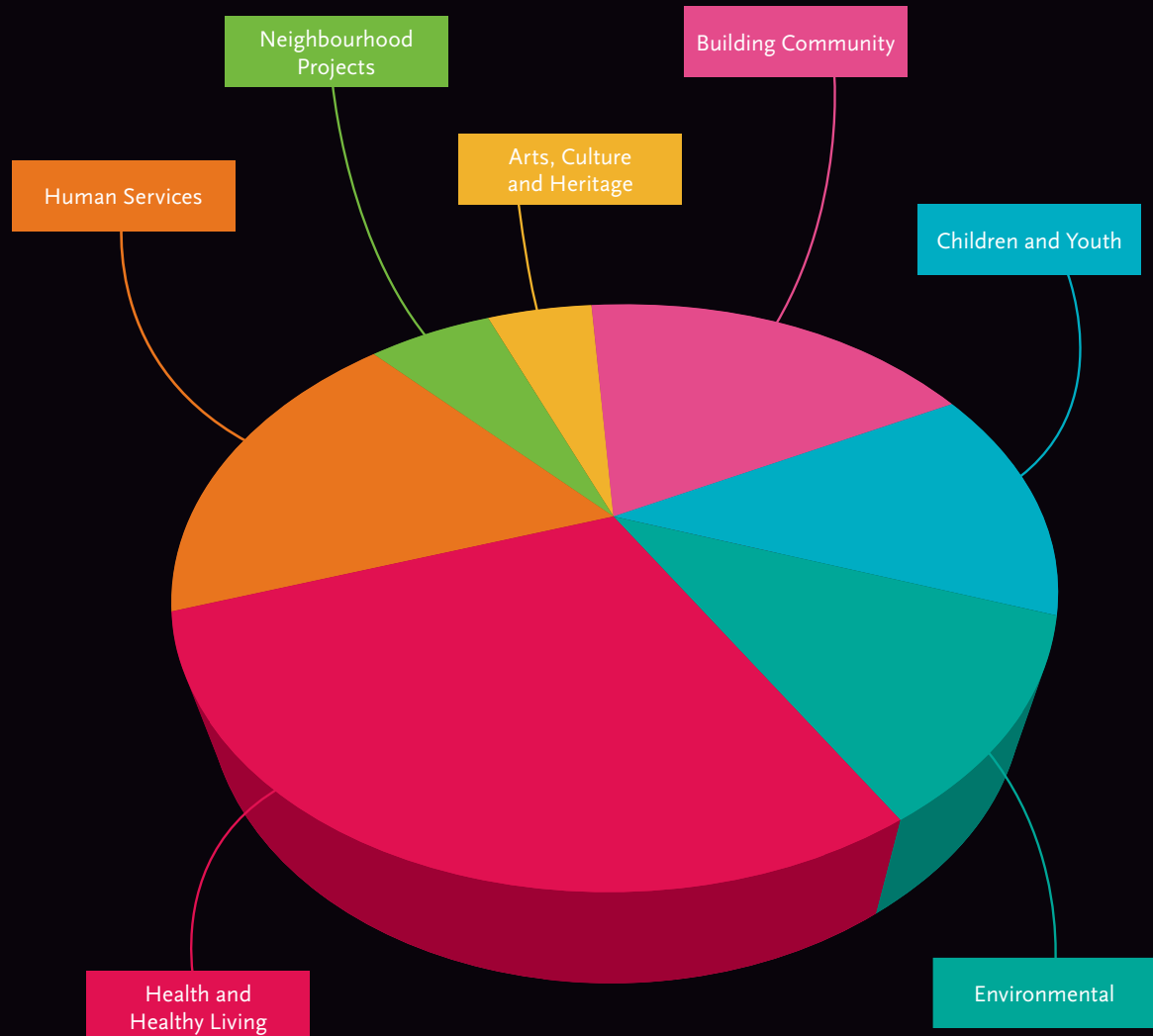

# OBLIGATION

## 1. SIGNIFICANT ACCOUNTING POLICIES

**Investments:** Investments are classified as “Held-for-Trading”, and as such are valued at the quoted market value. Investment income, including realized and unrealized capital gains net of losses, is allocated to the pool of Endowment Funds, Operating Funds and Funds Held for Others.

**Funds Held for Others:** Funds Held for Others represent community agency funds pooled with the Community Foundation of Mississauga for investment purposes. Investment income is allocated to the funds on a proportionate basis and the agencies are charged a management fee by the Foundation.

**Endowment Fund:** Donations to the Endowment Funds are considered to be permanent in nature, pursuant to restrictions established at the time that donations are received, and only the investment income from the investment of such Funds is disbursed to charitable organizations.

**Special Projects Reserve Fund:** Transfers to the Reserve Fund from the Operating Fund are to be used for expenditures in 2011 for the 10th anniversary of the Foundation.

## 2. INVESTMENT MANAGEMENT

Investments are professionally managed in accordance with the investment policy of the Foundation by Toronto Community Foundation, M.R.S. Securities, Investors Group and BMO Nesbitt Burns.
