Celebrating Ten Years of Growth and Vitality

Ask Merle Zoerb what it was that started it all and he would say, that it was a growing awareness of how community foundations were serving communities all across Canada and that Mississauga was the last large municipality that didn't have its own community foundation. For someone with a deep commitment to community service like Merle, that was simply not acceptable. There was a gap and there was work to be done to address that gap. And as someone who had given countless hours in community voluntarism, Merle simply got to work.

In 1997, Merle Zoerb and Laurie Pallett, then Executive Director of the Mississauga Arts Council made a presentation to City Council and indicated that the time was right to establish a community foundation to serve people in Mississauga. The Mississauga Arts Council got behind the effort and developed a feasibility study under the able guidance of Ruth Kitchen. A steering committee of dedicated volunteers was recruited and Colin Mason lent his expertise in helping to submit the necessary documents to incorporate and obtain registered charitable status.

In May 2001, the Community Foundation of Mississauga was born.

A few short paragraphs doesn't do justice to the hours of volunteer time given by so many people. Nor could they all be listed here. But what a legacy their efforts created!

In May 2011, the Community Foundation will celebrate ten years since it was incorporated. The Foundation has planned several special events and activities to help mark this first milestone. Both the web site and the newsletter will help keep people up to

From 2004 to the latest year of published statistics, it was Canada's fastest growing community foundation. This growth is a testament to the compassionate spirit of philanthropy that thrives in Mississauga.

By 2010, cumulative grant making of the Foundation had exceeded \$1.6 million and the Foundation has been the recipient of some of Mississauga's largest philanthropic gifts.

Endowments are created through the compassion and caring of donors. The growth of the Foundation has only been achieved

through donors who make gifts of all sizes because they believe in a better future for our community.

Ultimately, endowments are created by donors and stewarded through volunteer service so that the Foundation can create sustainable granting. 
Each of these remarkable people has left a lasting legacy for the benefit of the community. The Foundation will proudly honour their legacy in perpetuity.

The Ruth Gray Fund

St. Lawrence Starch founder John Gray immigrated to Canada from Scotland in 1873. In 1889 Gray, and three others founded St. Lawrence Starch at Port Credit, the site chosen for its proximity to Toronto, to the lake and to the railroad. The history of Port Credit is inextricably linked with the Gray family who built their successful company and provided employment for people in the community. St. Lawrence Starch supported many community initiatives. Their com-

pany provided important corporate sponsorship for both amateur and professional sports not just in the community but all across Canada. Last year, the Community Foundation of Mississauga was honoured to receive a bequest

from the estate of Mrs. Ruth Gray to establish a fund in her name. Mrs. Gray was married to John, the grandson of St. Lawrence Starch founder John Gray. She lived and participated in the life of Port Credit from 1946 until her death in 2010. Mrs. Gray wanted her gift to be used to benefit organizations serving children and youth. This fund will last in perpetuity ensuring a better future for children and youth and paying tribute to a family name that is part of the rich history of the community.

The Community Foundation of Mississauga makes its first grants from a flow through fund established by Baxter Corporation.

The first endowed fund, the Paul Coughlin Fund, is established through the support of Mary Hurley and the Mississauga Real Estate Board.

2001

The Community Foundation of Mississauga is established.

1992

Community Foundations of Canada, the national membership organization is formed.

1921

The first Canadian community foundation is established in Winnipeg.

1914

The first community foundation is established in Cleveland by Frederick H. Goff.

building community vitality.

The Foundation is now accepting nominations for the inaugural Pendle Award for Philanthropy. The deadline for receiving nominations is March 31st and the presentation to the first recipient will occur at the Annual General Meeting in May. The successful recipient will be selected by a committee of the Board and the Foundation extends appreciation to these volunteers who have stepped up to this task.
