One Million Moments

This spring, the Community Foundation of Mississauga awarded over \$1 million in grants to more than 60 registered charitable organizations serving people in Mississauga.

While the Foundation was thrilled to make these essential grants, we recognize that it is donors in Mississauga who have ultimately made this possible. Each year, more and more people, organizations and companies are recognizing that they can make lasting impact on quality of life in their community and that this impact can happen very quickly. We salute these caring donors who are truly all for community!

Here are some highlights of the initiatives that received funding...

Mississauga Heritage Foundation will move forward on Phase Two of its Sacred Garden honouring Aboriginal traditions. This includes completing the heritage plantings and installing a bench and solar lighting. Birch, sugar maple and white pine will be planted reflecting the indigenous species of 1847, as well as the sacred medicines of sweet grass, wild sage and ceremonial tobacco.

Square One Seniors Wellness Services will research the unique needs

of visually impaired older adults. One of the key barriers for accessing existing services is the lack of ability to safely and comfortably navigate into unknown geography or go out into the community as sighted people do. This research aims to identify gaps in programs and services.

Mississauga Symphony Orchestra is creating a local opera production! Throughout its history, Orchestras Mississauga has presented opera highlights concerts, all of which were well received and attended by the symphony audience.

Safe City Mississauga received results in March 2015 from a study on the impact of the Mississauga Neighbourhood Watch program. The report determined that the program did in fact reduce criminal activity in areas where it was implemented. Moving forward, the next step is to develop and refine this model, and share the findings.

Through the support of the Foundation, the Living Arts Centre will host its Second Annual Arts for Life Children's Festival. The Festival focuses on enriching school curriculum and promoting the arts as an integral part of children's ed-

ucation. There are four public productions planned in both theatres for a total of ten shows. Free outdoor programming and dance performances and workshops round out the event.

The Mississauga Furniture Bank received support to partner with the Niagara and Toronto Furniture Banks to build a Management Information System application that will be versatile, sustainable, sharable and mobile. This will allow for real time inventory management and efficient management of the pick-up and delivery service information resulting in administrative and operational efficiencies and potential cost of service reduction.

Bollywood Monster Mashup will return to Mississauga for the fifth time as the largest South Asian festival in Canada, with an anticipated 45 thousand attendees this year! This multiday festival showcases the talents of over 200 artists, integrating mainstream and ethnic communities and making the festival welcoming to all. This year there will be a Bollywood Latin Orchestra with Spanish dancers, Bollywood Tap Dance, and a fusion of Canadian sports (e.g., lacrosse) and South Asian sports.

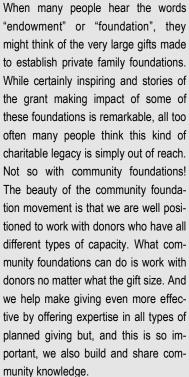
