2019 All for Community Speakers Event

On May 28th we welcomed Jeff Adams as keynote speaker for this year's "All For Community Speaker's Event". Jeff Adams is an accomplished Canadian Paralympian and world champion. He inspired our guests as he recounted his journey from the time spent as a youth on the family farm to Osgoode Hall law school, where he studies today. As a young boy, Jeff received life-saving radiation therapy that caused a spinal cord injury at age nine, leaving him without the use of his legs.

He was an active youth playing multiple sports, who now had to contend with using a wheelchair. His path in recovery ultimately took Jeff to the sport of wheelchair athletics and he competed at six consecutive Paralympics, winning a total of three gold, four silver, and six bronze medals throughout this time.

His post-sport days are just as exciting. Jeff started a wheelchair business, became a motivational speaker, became involved in

advocacy work, and is now a law student. He was inducted into Canada's Sports Hall of Fame and the Order of Ontario, and participates in the Law Society of Ontario Equity Advisory Group.

Jeff Adams was a tremendous guest speaker at our "All For Community: Inspire, Motivate, Energize" Speakers Event Breakfast. His story of excellence, perseverance and resilience was inspiring.
